That the City Manager is hereby authorized and empowered to do by City Forces all the work to wire and test the individual intersection controllers in connection with CONSTRUCTION OF MASTER CONTROL SYSTEM EXTENSION ON CLAIREMONT MESA BOULEVARD BETWEEN DOLIVA DRIVE AND RUFFIN ROAD AND ON CONVOY STREET BETWEEN CLAIREMONT MESA BOULEVARD AND ENGINEER ROAD pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City Forces more economically than if let by contract. The cost of said work shall not exceed \$5,500.
