A RESOLUTION DETERMINING AND DECLARING THAT THE PUBLIC INTEREST, CONVENIENCE AND NECES-SITY OF THE CITY OF SAN DIEGO REQUIRE THE CONSTRUCTION, RECONSTRUCTION, MAINTENANCE, OPERATION AND REPAIR OF A DRAIN OR DRAINS INCLUDING ANY AND ALL APPURTENANCES THERETO, TOGETHER WITH THE RIGHT OF INGRESS AND EGRESS, OVER, UNDER, ALONG AND ACROSS THAT PORTION OF PARCEL 70, LOT F, OF RANCHO MISSION OF SAN DIEGO, IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA, AND THAT THE PUBLIC INTEREST, CONVENIENCE AND NECES-SITY DEMAND THE ACQUISITION OF EASEMENTS AND TEMPORARY WORKING STRIPS IN SAID PROPERTY FOR SAID DRAIN OR DRAINS AND ANY AND ALL APPURTENANCES THERETO; AND DECLARING THE INTENTION OF THE CITY OF SAN DIEGO TO ACQUIRE SAID PROPERTY UNDER EMINENT DOMAIN PROCEEDINGS; AND DIRECTING THE CITY ATTORNEY OF THE CITY OF SAN DIEGO TO COMMENCE AN ACTION IN THE SUPERIOR COURT OF THE STATE OF CALIFORNIA, IN AND FOR THE COUNTY OF SAN DIEGO, FOR THE PURPOSE OF CONDEMNING AND ACQUIRING SAID PROPERTY AND ACQUIRING IMMEDIATE POSSESSION THEREOF; AND AUTHORIZING AND APPROVING THE EXPENDITURE OF \$3,000.00 THEREFOR.

WHEREAS, the Council of The City of San Diego has provided notice to those persons designated in Section 1245.235 of the Code of Civil Procedure and also has provided all persons a reasonable opportunity to appear and be heard on the matters referred to in Section 1240.030 of the Code of Civil Procedure; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. That the public interest, convenience and necessity of The City of San Diego, and the inhabitants thereof, require the construction, reconstruction, maintenance, operation and repair of a drain or drains including any and all appurtenances thereto, together with the right of ingress and egress, over, under, along and across that portion of Parcel 70, Lot F of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to the Map thereof made in San Diego Superior Court Case No. 15191, filed in the Office of the County Recorder of San Diego County, as more particularly described hereinafter.

Section 2. That the public interest, convenience and necessity of said City, and the inhabitants thereof, demand the acquisition and taking of drainage easements and temporary working strips to said property for the construction, operation and maintenance of a drain or drains including all appurtenances thereto, together with the right of ingress and egress, over, under, along and across said real property lying within the City of San Diego, County of San Diego, State of California.

Section 3. That Section 220, of the Charter of The City of San Diego; Sections 1240.010, 1240.110, 1240.120, 1240.610 and 1255.410, of the Code of Civil Procedure; Sections 5101(d) and 5102, of the Streets & Highways Code; and Sections 37350.5, 38900, 39040 and 40404, of the Government Code, permit the acquisitions referenced herein.

Section 4. That the parcels of real property and the interests sought to be condemned are described as follows:

### PARCEL 1 - DRAIN EASEMENT

The permanent easement and right-of-way to construct, reconstruct, maintain, operate and repair a drain or drains including any or all appurtenances thereto, together with the right of ingress and egress, over, under, along and across all that real property situated in the County of San Diego, State of California, described as follows:

All that portion of Lot F of Partition of a portion of Lot 70, Rancho Mission of San Diego, SCC Mp. 15191, as described in that certain Tax Deed recorded at File Page 80-231005 on July 23, 1980 in the Office of the County Recorder of San Diego County, State of California, being a strip of land 10-feet in width, lying parallel with, contiguous to, and Northeasterly of the following described line:

Commencing at the most Southerly corner of Lot 243 of Knollwood Park, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 7417, filed in the Office of the County Recorder of San Diego County on September 5, 1972. Thence along the Southeasterly line of said Lot 243, North 15°56'43" East, 55 feet to the TRUE POINT OF BEGINNING. Thence South 41°25'20" East, 203.88 feet; thence South 53°54'14" East, 216.31 feet to a terminus in the Southwesterly line of that certain existing 10-foot wide easement to the City of San Diego for drainage purposes, identified as "Parcel 5" of the deed recorded in the Office of the County Recorder of San Diego County, State of California on January 22, 1973 at File Page 73-018666.

The above described easement shall be prolonged so as to terminate Northwesterly in the Southeasterly line of Lots 242 & 243 of said Knollwood Park and to terminate Southeasterly in said existing 10-foot wide drainage easement.

### PARCEL 2B - TEMPORARY WORKING STRIP

Together with a temporary construction easement for the right, during construction of said drain or drains to use for purpose incidental to said construction, the land adjacent to the within-granted right-of-way, described as follows:

All that portion of Lot F of a Partition of a portion of Lot 70, Rancho Mission, SCC Map 15191, more particularly described as follows:

Commencing at the most Southerly corner of Lot 243 of Knollwood Park, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 7417, filed in the Office of the County Recorder of San Diego County on September 5, 1972. Thence along the Southeasterly line of said Lot 243, North 15°56'-43" East, 55 feet to the TRUE POINT OF BEGINNING of the parcel herein described. Said TRUE POINT OF BEGINNING is set forth and designated as Point A for purposes of this description. Thence leaving said Southeasterly line of Lot 243, South 41°25'20" East, 203.88 feet; thence South 53°54'14" East, 216.31 feet; thence South 56°05'23" East, 88.97 feet to a point on the Westerly sideline of the cul-de-sac of Town View Lake, being also the beginning of a non-tangent 45-foot-radius curve, concave Southeasterly, a radial to said curve bears North 51°16'04" West, thence Southerly along the arc of said curve through a central angle of 8°41'46", an arc distance of 6.83 feet; thence leaving said sideline, South 72°40'32" West, 24.92 feet; thence North 73°03'50" West, 15.24 feet; thence North 56°05'23" West, 68.11 feet; thence South 73°03'50" East, 68.50 feet; thence North 56°05'23" West, 56.21 feet; thence

North 53°54'14" West, 217.40 feet; thence North 41°25'20" West, 198.57 feet to said Southeasterly line of Lot 243; thence along said Southeasterly line, North 15°56'43" East, 12.35 feet to the TRUE POINT OF BEGINNING.

## PARCEL 3A - TEMPORARY WORKING STRIP

Together with a temporary construction easement for the right, during construction of said drain or drains to use for purpose incidental to said construction, the land adjacent to the within-granted right-of-way, described as follows:

All that portion of Lot F of a Partition of a portion of Lot 70, Rancho Mission, SCC Map 15191, more particularly described as follows:

Commencing at Point A as set forth and described in Parcel 2B: thence along said Southeasterly line of Lot 243, South 15°56'43" West, 12.35 feet to the TRUE POINT OF BEGINNING; thence leaving said Southeasterly line South 41°25'20" East, 198.57 feet; thence South 53°54'14" East, 217.40 feet; thence South 56°05'23" East, 56.21 feet; thence North 73°03'50" West, 68.50 feet; thence North 53°54'14" West, 210.28 feet; thence North 41°25'20" West, 187.95 feet to said Southeasterly line of Lot 243; thence along said Southeasterly line of Lot 243, North 15°-56'43" East, 23.75 feet to the TRUE POINT OF BEGINNING.

## PARCEL 1A - TEMPORARY WORKING STRIP

Together with a temporary construction easement for the right, during construction of said drain or drains to use for purpose incidental to said construction, the land adjacent to the within-granted right-of-way, described as follows:

All that portion of Lot F of a Partition of a portion of Lot 70, Rancho Mission, SCC Map 15191, more particularly described as follows:

Commencing at Point A as set forth and described in Parcel 2B; thence along said Southeasterly line of Lot 243, North 15°-56'43" East, 11.88 feet to the TRUE POINT OF BEGINNING; thence along the Southeasterly line of Lot 242 of said Knollwood Park, North 15°56'43" East, 35.62 feet; thence leaving said Southeasterly line, South 41°25'20" East, 225.16 feet; thence South 53°54'14" East, 270.86 feet to a point on the westerly sideline of Lot 76 of the Knolls of Del Cerro Unit No. 2 according to Map thereof No. 6918, filed in the Office of the County Recorder of San Diego County, State of California; thence along said Westerly sideline of Lot 76, South 7°00'37" East, 40.34 feet; thence leaving said Westerly sideline of Lot 76, North 56°05'23" West, 85.35 feet; thence North 33°54'37" East, 0.007 feet; thence North 53°54'14" West, 214.80 feet; thence North 41°25'20" West, 209.23 feet to the TRUE POINT OF BEGINNING.

Section 5. That the taking and acquiring by said City of the easements hereinabove described is deemed necessary for the construction, reconstruction, maintenance, operation and repair of a drain or drains including any and all appurtenances thereto, together with the right of ingress and egress, over, under, along and across said property, by The City of San Diego and the inhabitants thereof, for municipal purposes; that such uses are public uses authorized by law (Section 220, of the Charter of The City of San Diego; Sections 1240.010, 1240.110, 1240.120, 1240.610 and 1255.410, of the Code of Civil Procedure; Sections 5101(d) and 5102, of the Streets & Highways Code; and Sections 37350.5, 38900, 39040 and 40404, of the Government Code); that for such public uses it is necessary that The City of San Diego condemn and acquire said property interests; that

said property interests are to be used for the construction, reconstruction, maintenance, operation and repair of a drain or drains including any and all appurtenances thereto, together with the right of ingress and egress, over, under, along and across said property, which are planned and located in a manner most compatible with the greatest public good and the least private injury.

Section 6. The City Council hereby makes the following findings in support of the above-referenced findings contained in Paragraph 5 herein: (a) The proposed project for which this acquisition is being sought is to improve the storm drain system on Hillandale Drive from Hillandale Court on the south to Deerfield Drive on the north; and (b) the proposed project will prevent flooding to adjacent private properties.

Section 7. That an offer to acquire said property interests at the appraised fair market value has been made to the owners of the property pursuant to Section 7267.2 of the Government Code and rejected.

Section 8. That the City Attorney of The City of San Diego be, and he is hereby authorized and directed to commence an action in the Superior Court of the State of California, in and for the County of San Diego, in the name and on behalf of The City of San Diego, against all owners and claimants to an

interest in the above-described real property, for the purpose of condemning and acquiring the drainage easements as above-described, and obtaining immediate possession of said parcels for the use of said City.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$3,000.00 from Revenue Sharing Fund 18013
CIP No. 12-049.0, Hillandale Drive Drain, is hereby authorized and approved solely and exclusively for the above purpose.
