This is the remainder of his award.
Burness Gipson	Water Utilities	\$ 680.00	Mr. Gipson is an Equipment Technician II in the Metro Division. One year ago he earned a partial award of \$440 for his suggestion to place a scrap metal bin at the Point Loma Treatment Plant. One year's experience has resulted in revenue of \$3,730.87. This is the remainder of his award.
