David Lindmeier Clyde Kirkpatrick Richard Vargas	General Services	\$75.00	Mr. Lindmeier is a Senior Motive Service Technician and Messrs. Kirkpatrick & Vargas are Motive Service Technicians. They suggested the installation of cement guards around the conduit for the fuel island terminals. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Robert Sherer	Police	\$70.00	Mr. Sherer is a Stock Clerk at Northern Division. He suggested that picture frames be purchased from a different vendor. A savings of \$234 was realized between November and June.
Don Pyke	Water Utilities	\$50.00	Mr. Pyke is an Administrative Analyst at the Metro Division. He suggested that all Purchasing Buyers utilize electronic mail. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Nancy Lovell	General Services	\$20.00	Ms. Lovell is a Payroll Clerk in the Streets Division. One year ago she earned a partial award of \$45 for her suggestion to have Personnel and Auditors figure final termination pay-offs. One year's experience has shown a savings of \$214.87 in time. This is the remainder of her award.
