RESOLUTION OF THE COUNCIL OF THE CITY OF SAN
DIEGO DESIGNATING THE COLLEGE GROVE
REDEVELOPMENT SURVEY AREA.

WHEREAS, Division 24, Part 1, of the California Health and Safety Code (hereinafter referred to as "Community Redevelopment Law") provides that in order to invoke the provisions of said Law to effectuate the redevelopment of blighted areas, there shall be a designation of such area pursuant to Section 33310 of the Community Redevelopment Law; and

WHEREAS, the owner and developer of the College Grove Shopping Center, College Grove Ltd., has submitted a written request pursuant to Section 33310 of the Community Redevelopment Law to the Council of The City of San Diego requesting the City Council to designate a survey area for project study purposes encompassing the College Grove Shopping Center and certain public properties and right-of-way; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The College Grove Redevelopment Survey Area (hereinafter referred to as "College Grove Survey Area") is hereby designated as a survey area, and said area is generally bounded by Highway 94 on the south, College Avenue on the east, College Grove Drive on the north, and College Grove Way on the west, and including a portion of Chollas Lake Community Park. The College Grove Survey

Area is more specifically shown on Attachment A, attached hereto and incorporated herein.

2. It is hereby found and determined that the Area described in Section 1 hereof requires study to determine if a redevelopment project or projects within said Area are feasible.

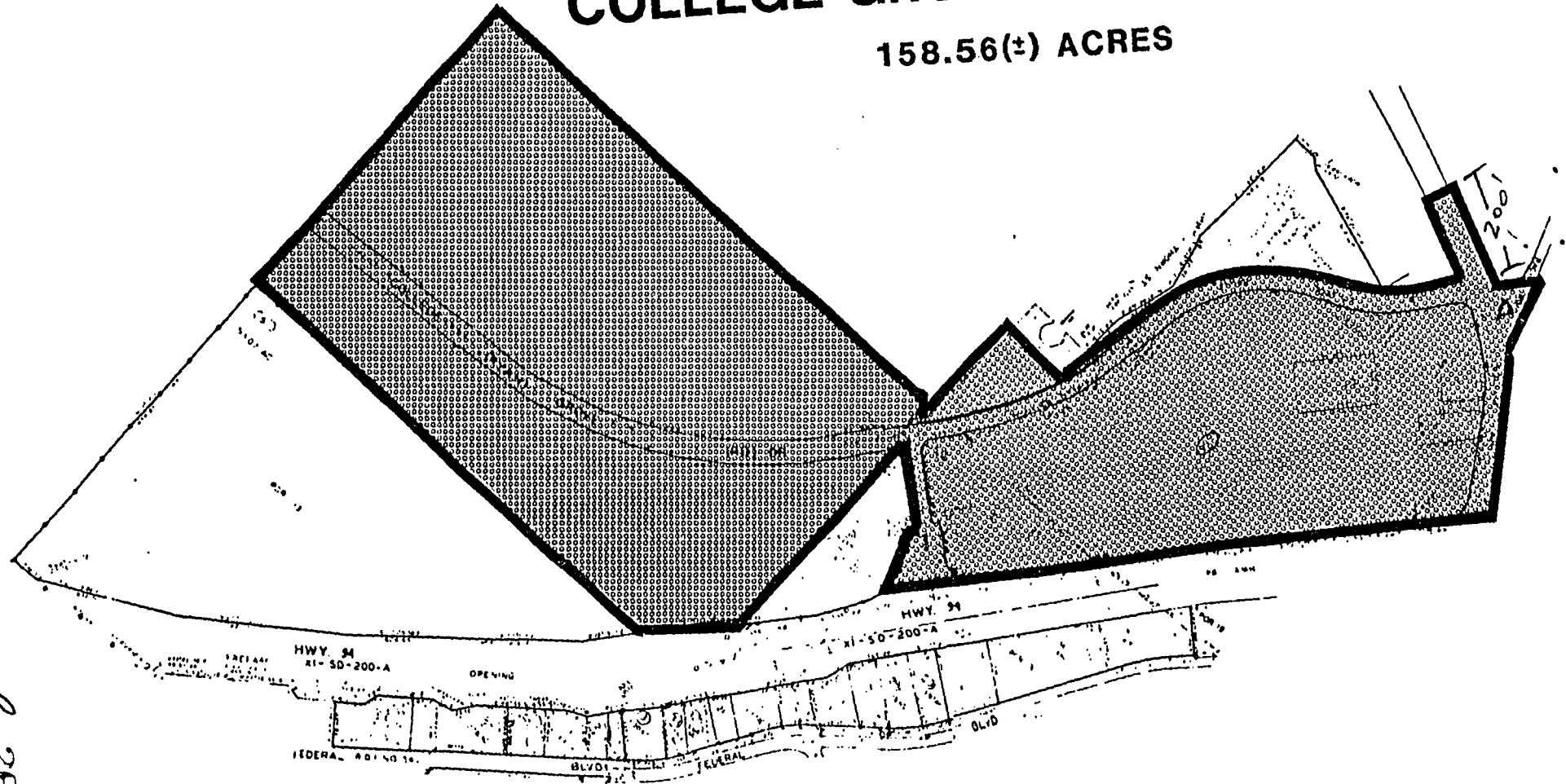
