WHEREAS, the Smith Hanna Medical Group in North Park was the first Smith Hanna medical center established in San Diego County; and


WHEREAS, the Smith Hanna Medical Group in North Park has continuously provided quality medical care to North Park and surrounding communities since 1937; and
