RESOLUTION NUMBER R- 264140

ADOPTED ON SEP 24 1985

WHEREAS, on September 30, 1984, Governor Deukmejian signed Senate Bill 2049, enabling the California Conservation Corps (CCC) to expand its nonresidential program; and

WHEREAS, approximately \$565,000 has been designated for expansion of the nonresidential program; and

WHEREAS, the CCC is currently soliciting proposals from local government entities to establish a CCC nonresidential satellite in their community; and

WHEREAS, the recent fire in Normal Heights has focused attention on the great problem of fuel load in the City's canyon areas, reinforced by the preliminary findings of the Canyon Rim Fire Prevention Task Force; and

WHEREAS, approximately \$117,480 covering a crew of fifteen corps members would be made available to the City to assist with such projects as fire prevention and suppression, restoration of burned hillsides and park construction and rehabilitation, among others; and

WHEREAS, this program would, at the same time, provide employment, skills and development of the work ethic in young people; and

WHEREAS, the City would have the opportunity to utilize the CCC programs to implement projects otherwise prohibitive for lack of resources; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to submit a proposal to the California Conservation Corps to establish a California Conservation Corps nonresidential satellite in San Diego.
