BE IT FURTHER RESOLVED, that the Fire Marshal be hereby authorized to bill the property owners for the cost of abatement as confirmed.


BE IT FURTHER RESOLVED, that the costs of weed abatement against the following parcels are disallowed and shall not be billed against the affected property owners:
