
WHEREAS, on July 1, 1985, the San Diego City Council unanimously approved Resolution No. R-263558 which requested the City Attorney to continue discussions with the insurance industry for the purpose of drafting viable reforms to the current joint and several liability doctrine;

WHEREAS, it is deemed appropriate at this time to reaffirm such approach for resolution of the issue; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council reaffirms its position that the most meaningful joint and several liability reform will result if a coalition of private and public sector interest groups, including but not limited to cities, the County Supervisors Association of California, the California Medical Association and the insurance industry, all concur in any proposal to reform the current law.
