

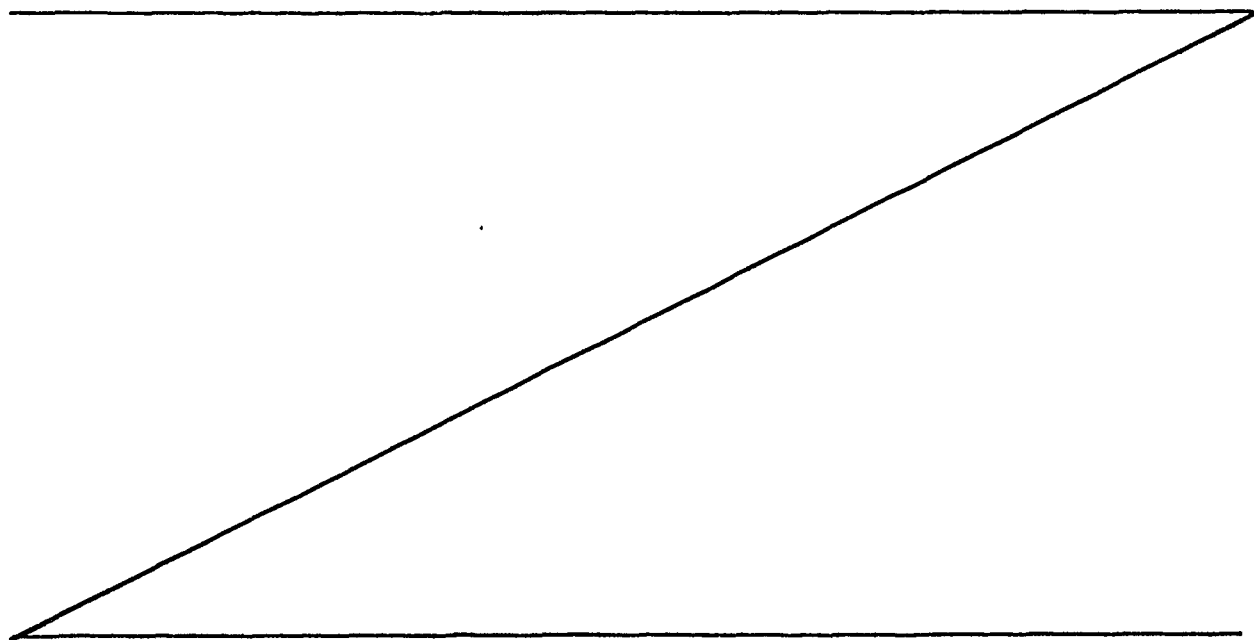

RESOLUTION NUMBER R- 264176

ADOPTED ON SEP 30 1985


BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of Section 85.02 of the San Diego Municipal Code, a TRUCK PARKING PROHIBITED ZONE, be and the same is hereby established on both sides of the following streets:

Shawline Street from Clairemont Mesa Boulevard southward to Ronson Road; Shawline Court; Cardin Street from Ronson Road southward to Opportunity Road; Ronson Road from Shawline Street eastward to Kearny Mesa Road; Kearny Villa Road from Highway 163 northward to Kearny Villa Court; Mercury Street from Balboa Avenue southward to Armour Street; Kearny Mesa Road from Armour Street to Convoy Street; Engineer Road from Cardin Street eastward to Kearny Mesa Road; Kearny Mesa Road from Balboa Avenue northward to its terminus.



BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
