

RESOLUTION No. R-264187

(R. 86-406)

Adopted on OCT 14 1985

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bids of (1) JOHN C. HENBERGER CO. INC. and (2) BALTIMORE PAINT & CHEMICAL CO. DIV. THE SHERWIN-WILLIAMS CO. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of HOT INSTANT DRY TRAFFIC PAINT (YELLOW AND WHITE) as may be required for a period of two (2) years beginning December 1, 1985 through November 30, 1987 with options to renew contract for up to two (2) additional one (1) year periods with prices after the first contract year to be increased or decreased every six (6) months in an amount directly proportional with the Producer Price Index published by U.S. Department of Labor, Bureau of Labor Statistics, for the groupings "Prepared Paint" and "Paint Materials", using the average of these two indexes; and with the option to cancel at the end of each fiscal year if the City fails to provide funding for the purchase of traffic paint, as follows:

- (1) J. C. HENBERGER CO. INC. - Item 1, Yellow Instant Dry Traffic Paint at a cost of \$5.45 per gallon, for a total estimated cost of \$65,400.00; terms net 30 days, plus sales tax, plus refundable drum deposit charges of \$10.00 each.

- (2) BALTIMORE PAINT & CHEMICAL CO., DIV. THE SHERWIN WILLIAMS CO. - Item 2, White Instant Dry Traffic Paint at a cost of \$5.11 per gallon, terms net 30 days, plus sales tax, plus a refundable drum deposit charge of \$4.50 each.

2. That the Purchasing Agent is hereby authorized to obtain this material on an emergency basis in the event either of the successful contractors are unable to deliver paint meeting these specifications in the stated delivery time in accordance with the emergency price clause of the specifications.
