WHEREAS, Section 8330, et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where the portion of street to be vacated has been superseded by relocation; and

WHEREAS, the abutting property owners have requested the vacation of Morena Boulevard a portion of Block 7, Homeland Villas, Map 1010, and Blocks 11 and 12 of American Park Addition, Map 983. Brandywine Street adjacent to Blocks 11 and 12 and alley in Block 12, all of American Park Addition, Map 983, all within the Sumner Center Subdivision (T.M. 82-0036) boundaries, to facilitate development of their property; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated through will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE'IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Morena Boulevard a portion of Block 7, Homeland Villas, Map 1010, and Blocks 11 and 12 of American Park Addition,

Map 983. Brandywine Street adjacent to Blocks 11 and 12 and alley in Block 12, all of American Park Addition, Map 983, all within the Sumner Center Subdivision T.M. 82-0036, as more particularly shown on Drawing No. 21009-D, on file in the office of the City Clerk as Document No. RR-2642077, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

- 2. That the resolution shall not become effective unless and until the Sumner Center Subdivision (T.M. 82-0036) has been approved by Council action. In the event that the final map is not approved by August 25, 1988, this resolution shall become void and of no further force or effect.
- 3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned map, and that the City Clerk shall then cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.


