RESOLUTION NUMBER R- 264221

ADOPTED ON OCT 14 1985

WHEREAS, by Resolution No. R-259945, this Council approved the Rancho Bernardo Financing Plan on January 10, 1984; and

WHEREAS, the traffic flow characteristics have proven to be different from the initial traffic flow characteristics upon which the predictions of the traffic signal demand contained in that plan were forecast; and

WHEREAS, the calculation system for traffic warrants for intersection signalization at the Federal and State level have recently been revised; and

WHEREAS, the intersection of Via Frontera and West Bernardo Drive now meets the warrants required to justify its signalization; and

WHEREAS, the City Manager has recommended that this intersection be included in the facilities to be financed under the Traffic Signal Charge currently being levied in Rancho Bernardo; NOW, THEREFORE

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Rancho Bernardo Financing Plan be and is hereby modified to add the intersection of Via Frontera and West Bernardo Drive as an intersection at which signalization is appropriate.

2. That the intersection of Via Frontera and West Bernardo Drive be scheduled on page 32 of the Rancho Bernardo Financing Plan as a 1986 project with appropriate Traffic Signal Charge financing for signalization.
