WHEREAS, the Public Services and Safety Committee on October 2, 1985, in response to a request to fund the Salvation Army Emergency Shelter for one month at a cost of \$4,200, approved an advance of City funds, to be repaid prior to the end of Fiscal Year 1986; and

WHEREAS, the funds would pay a pro-rata City portion for one month's lodging for eighty homeless men in the downtown emergency shelter; and

WHEREAS, the County of San Diego has agreed to a contribution of a similar amount; and

WHEREAS, the City's advance would be made payable to the United Way of San Diego County which is acting as Fiscal Agent for the Regional Task Force on the Homeless and the funds would be repaid to the City prior to June 30, 1986 through fundraising efforts which will occur in the beginning of calendar year 1986; and

WHEREAS, the requested dollars will allow the Salvation Army Shelter to remain open during the period when private dollars are expected to run out and federal dollars are expected to start; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with UNITED WAY OF SAN DIEGO COUNTY, a California nonprofit charitable corporation, to secure thirty nights of lodging at the downtown Salvation Army Emergency Shelter for eighty homeless men during the period October 1985, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-264234.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to expend from the General Fund 100, Unallocated Reserve (Dept. 605, Org. 60531, Object Account 4903) and pay over to the United Way of San Diego, an amount not to exceed \$4,200, for the sole and exclusive purpose of performing the above-cited agreement and duties recited therein.
