WHEREAS, the Southern California Coastal Water Research Project Authority (SCCWRPA) is an agency established pursuant to a Joint Powers Agreement, to which The City of San Diego is a party; and

WHEREAS, the purpose of said SCCWRPA is to conduct scientific research directed at assessing the impact of wastewater discharge on the marine environment of the Southern California Coast, determining cause-effect relationships relative to those impacts and developing predictive models to aid in decisions regarding levels of wastewater treatment required to protect the marine environment; and


WHEREAS, The City of San Diego is a member of the SCCWRPA and has a member appointed thereto by the Council of said City; and
