RESOLUTION NUMBER R- 264271 ADOPTED ON OCT 21 1985

WHEREAS, the action herein involves the acquisition by the City of San Diego of 1.55 additional acres of land in the Mira Mesa area for Winterwood Lane Community Park; and

WHEREAS, on October 31, 1983, the Subdivision Review Board approved the tentative map for Mesa Summit Unit 5, pursuant to Subdivision Review Board Resolution 3720, and Condition 16 of this resolution required the property owner to enter into a two-year option agreement with the City for purchase of the proposed park land; and

WHEREAS, the City has exercised its option to acquire the property in accordance with this agreement (approved by Council on February 25, 1985), subject to acceptance of the deed by the City Manager; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby fully authorized and empowered to accept a Grant Deed executed by PARDEE CONSTRUCTION COMPANY, a California corporation, conveying to the City of San Diego that parcel of land identified as Lot 125 of Mesa Summit Unit 5 located north of Mira Mesa Boulevard and east of Wallingford Road in the Mira Mesa area, a copy of which Grant Deed is on file in the office of the City Clerk as Document No. RR-264271.

- 2. That pursuant to the provisions of the annual appropriations ordinance, the Fiscal Year 1986 Capital Improvement Program be and the same is hereby amended by adding thereto Capital Improvement Project No. 29-423.2 Winterwood Lane Community Park Acquisition.
- 3. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$146,000 from the Park Service District Fund 13210 to the newly created project CIP No. 29-423.2 Winterwood Lane Community Park Acquisition.
- 4. That the Auditor and Comptroller be and he is further authorized to expend the sum of \$146,000 from CIP No. 29-423.2 for acquisition and related expenses for the newly created project.
