Barbara Thompson	Utilities	\$380.00	Ms. Thompson is the Principle Clerk in the Customer Service Division. She suggested the use of an answering machine to convey agency locations for water bill payments. This has resulted in an estimated savings of \$2,534.01. This is a partial award pending a 12-month review.
Jerry Vistercil	General Services	\$305.00	Mr. Vistercil was the Repair Supervisor in the Equipment Division at the time of this suggestion. One year ago he earned a partial award of \$295 for this suggestion to render the fan clutches on the rubbish packing vehicles inoperative. This has resulted in actual savings of \$2,006.56. This is the remainder of his award.
David Jacks	Utilities	\$280.00	Mr. Jacks is a Equipment Mechanic with the Equipment Division of General Services. He suggested the modification of the idler pulley on the leak trucks. Although savings were difficult to identify, this was considered to be a significant operational improvement.
