Danny Lenz Roy Miles	General Services	\$170.00	Mr. Lenz is a Paint Supervisor and Mr. Miles is a Carpenter in the Buildings Division. They suggested the use of paint instead of varnish on selected exterior doors of City Facilities. This has resulted in a estimated savings of \$564.25. This is a partial award pending a 12-month review.
Fred Wood	Utilities	\$160.00	Mr. Wood is a Plant Operator at the Point Loma Treatment Plant. He suggested the installation of a plywood surface over the floating catwalks rungs on the digestors at Point Loma. Although savings were difficult to identify, this was considered to be a significant safety improvement.
