


RESOLUTION No. R-264315 (R-86-643)

Adopted on OCT 28 1985

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for MAINTENANCE SURFACING VARIOUS CITY STREETS - GROUP "V" FY '86, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on OCT 28 1985 and bearing official Document No. RR-264315 be, and the same are hereby approved.
2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for MAINTENANCE SURFACING VARIOUS CITY STREETS - GROUP "V" FY '86.
4. That the City Auditor and Comptroller is hereby authorized to transfer \$145,000 from the Water Revenue Fund 41502 Unallocated Reserve 70679 to Water Operating Fund 41500, Water Main Maintenance Program 70540.
5. That the City Auditor and Comptroller is hereby authorized to transfer \$353,000 within the Sewer Revenue Fund 41506 from the Unallocated Reserve 70697 to the Sewer Main Maintenance Program 70440.
6. That the expenditure, not to exceed \$6,391,901 (\$5,525,901 from Gas Tax Fund 30219; \$478,000 from Water Utility Operating Fund 41500, and \$388,000 from Sewer Revenue Fund 41506) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
