- 4. That the City Auditor and Comptroller is hereby authorized to transfer \$145,000 from the Water Revenue Fund 41502 Unallocated Reserve 70679 to Water Operating Fund 41500, Water Main Maintenance Program 70540.
- 5. That the City Auditor and Comptroller is hereby authorized to transfer \$353,000 within the Sewer Revenue Fund 41506 from the Unallocated Reserve 70697 to the Sewer Main Maintenance Program 70440.
- 6. That the expenditure, not to exceed \$6,391,901 (\$5,525,901 from Gas Tax Fund 30219; \$478,000 from Water Utility Operating Fund 41500, and \$388,000 from Sewer Revenue Fund 41506) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
