RESOLUTION NUMBER R- 264341

ADOPTED ON OCT 28 1985

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provide a procedure for the summary vacation of streets and public service easements by City Council resolution; and

WHEREAS, the resolution of vacation may provide that the vacation occurs only after conditions required by the legislative body have been satisfied and may instruct the City Clerk that the resolution of vacation not be recorded until the conditions have been satisfied; and

WHEREAS, Resolution of Vacation No. R-259476, adopted by the City Council on October 24, 1983, provided that the vacation occur only after Parcel Map T.M. 82-0470 was approved; and

WHEREAS, in the event the parcel map was not approved by October 31, 1985, Resolution No. R-259476 would become void and be of not further force or effect; and

WHEREAS, the owner of Parcel Map T.M. 82-0470 has requested that the expiration date be amended to April 30, 1986; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Resolution of Vacation No. R-259476 adopted by the City Council on October 24, 1983, and on file in the office of the City Clerk, be and the same is hereby ordered amended as

follows: That in the event Parcel Map T.M. 82-0470 is not approved by April 30, 1986, this Resolution shall become void and be of no further force or effect.

2. That the City Engineer shall advise the City Clerk of the approval of the aforementioned parcel, and that the City Clerk shall then cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
