BE IT FURTHER RESOLVED, that the expenditure not to exceed \$35,000 from CIP \$35-055, Central Library-Renovation, is hereby authorized solely and exclusively for the execution of the above consulting service agreements and related costs, and further

authorizing the City Auditor and Comptroller to transfer unexpended funds to the appropriate reserves upon the advice of the administering department.
