WHEREAS, The City of San Diego has entered into an agreement with the Centre City Development Corporation ("CCDC") for the preparation of an analysis of a development plan for the Community Concourse; a copy of said agreement is on file in the office of the City Clerk as Document No. RR-260337; and


WHEREAS, the Council of The City of San Diego on September 9, 1985, authorized CCDC to more fully investigate the construction of a central library at the Community Concourse; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to extend the agreement with CCDC for the continued study of a development plan for the Community Concourse.

BE IT FURTHER RESOLVED, that the appropriation of \$155,000.00 from repayment by the Redevelopment Agency of The City of San Diego and the expenditure of up to \$155,000.00 from the Transient Occupancy Tax Fund, Fund No. 10224, to reimburse CCDC for the costs incurred, is hereby authorized.
