RESOLUTION NUMBER R- 264376

ADOPTED ON NOV 4 1985

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provide a procedure for the summary vacation of streets by City Council resolution where for a period of five consecutive years, the street to be vacated has been impassable for vehicular travel and during such period, no public money has been expended for maintenance; and

WHEREAS, the abutting property owners have requested the vacation of Albatross Street between Spruce Street and Redwood Street, for the preservation of an inner-City canyon; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Albatross Street, between Spruce Street and Redwood Street as more particularly shown on Drawing No. 16425-B, on file in the office of the City Clerk as Document No. RR- 264376, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall then cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

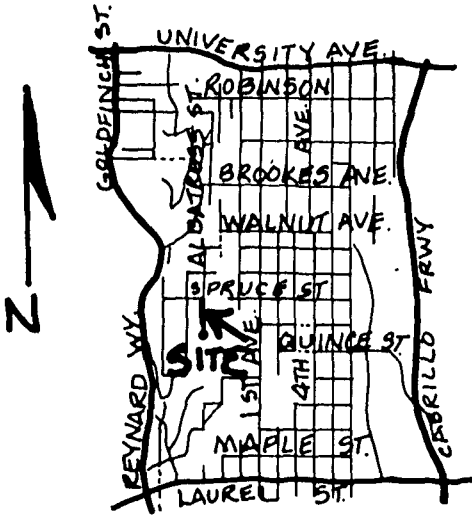
