BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller be and he is hereby authorized to transfer the amount of \$5,000 within Fund 100 from the Unallocated Reserve (605) to the Allocated Reserve (901) for the sole and exclusive purpose of providing funds to augment Resolution No. R-262840 for expenses incurred in connection with said participation in the above California Public Utilities Commission rate hearings relating to the Pacific Telephone and Telegraph Company.
