WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provide a procedure for the summary vacation of streets by City Council resolution where the portion of street to be vacated consists of a portion of a street or highway that lies within property under one ownership and that does not continue through such ownership or end touching property of another; and

WHEREAS, the abutting property owners have requested the vacation of Toni Ridge Place adjacent to Lots 58 through 63 of Carroll Ridge Unit No. 4, Map 10953, to facilitate development of their property; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Toni Ridge Place adjacent to Lots 58 through 63 of Carroll Ridge Unit No. 4, Map 10953, as more particularly shown on Drawing No. 16315-1-B, on file in the office of the City Clerk

as Document No. RR- 264403-/, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

- 2. That the resolution shall not become effective unless and until Parcel Map T.M. 84-0694 has been approved by the City Engineer. In the event that the final map is not approved by October 31, 1986, this resolution shall become void an be of no further force or effect.
- 3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned parcel map, and that the City Clerk shall then cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
