WHEREAS, the development of the Mission Trails Regional Park is of continuing interest to The City of San Diego; and

WHEREAS, the San Diego Community Foundation was established in 1975 with two basic directions: to stimulate the establishment of endowments to serve the San Diego community and to help address community needs by providing leadership and resources; and

WHEREAS, with the assistance of the City's Endowment Officer, the Mission Trails Regional Park Citizens' Advisory Committee has established an endowment fund within the San Diego Community Foundation, Inc., to benefit Mission Trails Regional Park; and

WHEREAS, several endowment funds to benefit the City are already entrusted to the Foundation; and

WHEREAS, the intent of the recently established endowment fund is to generate private donations to be used to benefit the Mission Trails Regional Park; and

WHEREAS, use of available endowment funds, subject to any donor stipulations, will be proposed by the Citizens' Advisory Committee, subject to confirmation by the Task Force and the normal City review process; and

WHEREAS, it has now been proposed that The City of San Diego, together with the County of San Diego and the City of La Mesa, contribute to an endowment fund to permit the realization of such development; and

WHEREAS, the Council of The City of San Diego finds that a requested donation of \$5,000 on behalf of the citizens of San Diego is a reasonable and proper expenditure of funds for park endowment purposes; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of said City, does hereby approve the allocation of \$5,000 from Department 10580, Account No. 4279, Job Order 015080, for the Mission Trails Regional Park and directs the Auditor and Comptroller to expend and pay over, as The City of San Diego's donative portion, said \$5,000 to the San Diego Community Foundation, Inc., for the Mission Trails Regional Park Endowment Fund, for the purposes herein expressed.
