

RESOLUTION No. R- 264447 (R- 86-776)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for STREET LIGHT CONVERSION - CITYWIDE, CONTRACT NO. 2, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on NOV 18 1985 and bearing official Document No. W.D. 122416 be, and the same are hereby approved.
2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for STREET LIGHT CONVERSION - CITYWIDE, CONTRACT NO. 2.
4. That the expenditure from Gas Tax Fund 30219, authorized by Resolution No. 261382, adopted on August 20, 1984, for Street Light Conversions - Citywide, Contract No. 1 is hereby decreased by \$80,102.
5. That the expenditure, not to exceed \$370,747 from Gas Tax Fund 30219 CIP No. 37-310 STREET LIGHT CONVERSION is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, to retain excess budgeted funds, if any, in CIP No. 37-310 STREET LIGHT CONVERSION.
