
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a first amendment to the Agreement with Biggs Engineering Corporation, for professional engineering services in connection with providing bicycle lanes on Nimitz from Harbor Drive to West Point Loma Boulevard, and on Genesee Avenue from Nobel Drive to the AT&SF Bridge and from Eastgate Mall to Campus Point Drive, under the terms and conditions set forth in the First Amendment to Agreement on file in the office of the City Clerk as Document No. RR- 264472.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to add \$160,000 to C.I.P. 58-044 Genesee Avenue Bikeway I from FBA Fund 79001 Genesee Avenue.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$6,000 from Fund 79001, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
