



BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an amendment to agreement with NORMAL HEIGHTS COMMUNITY DEVELOPMENT CORPORATION, which amendment would increase the amount in Fund 18521, Dept. 5835, Org. 3505, from \$37,600 to \$38,579, and in Fund 18519, Dept. 5717, Org. 1705, from \$10,340 to \$10,610, under the terms and conditions set forth in that amendment to agreement on file in the office of the City Clerk as Document No. RR- 264473.
