ADOPTED ON NOV 25 1985

BE IT RESOLVED, by the Council of The City of San Diego, that the period of November 25 through December 25, 1985 be proclaimed "Operation Care and Share Month" in The City of San Diego.

BE IT FURTHER RESOLVED, that all the people of this fine City that are capable of so doing, be and they are encouraged to participate in this humanitarian event.
