RESOLUTION NUMBER R- 264436

RESOLUTION DECLARING THE RESULTS OF THE  
GENERAL MUNICIPAL ELECTION AND THE SPECIAL  
MUNICIPAL ELECTION HELD IN THE CITY OF SAN  
DIEGO ON NOVEMBER 5, 1985.

WHEREAS, a general municipal election was held in the City of San Diego on Tuesday, November 5, 1985, pursuant to the provisions of Ordinance No. O-16483 (New Series), for the purpose of electing councilmembers; and

WHEREAS, a special municipal election was held in the City of San Diego on the same date pursuant to the provisions of Ordinance No. O-16473 (New Series) adopted July 22, 1985, which special municipal election was consolidated with the general municipal election for the purpose of submitting to the qualified voters of the City of San Diego one proposition to amend the Charter of The City of San Diego as follows:

PROPOSITION A

PROPOSITION A. CITY OF SAN DIEGO INITIATIVE  
MEASURE. AMENDS THE CITY OF SAN DIEGO  
PROGRESS GUIDE AND GENERAL PLAN.

Shall the City of San Diego Progress Guide and  
General Plan be amended by adding restrictions  
requiring that land areas which are designated  
as "future urbanizing" not be redesignated  
without voter approval?

WHEREAS, a copy of the certificate of the Registrar of Voters of San Diego County canvassing the returns of the general municipal election and the special municipal election, as certified to the City Clerk, has been duly received; and

WHEREAS, a canvass of these elections has been completed and the City Clerk has certified the results to the City Council;  
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds and determines pursuant to the provisions of Section 27.2206 of the San Diego Municipal Code, as follows:

I

The whole number of votes cast in the City was 141,847.

II

The total vote received by each municipal candidate at the general municipal election is as follows:

A. FOR COUNCILMEMBER DISTRICT NO. 1 (four-year term):

ABBE WOLFSHEIMER having received a majority of all votes cast is hereby declared elected to the office of Councilmember District No. 1.

B. FOR COUNCILMEMBER DISTRICT NO. 3 (four-year term):

GLORIA DEMERS McCOLL having received a majority of all votes cast is hereby declared elected to the office of Councilmember District No. 3.

C. FOR COUNCILMEMBER DISTRICT NO. 5 (four-year term):
