BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of Section 85.02 of the San Diego Municipal Code, a TRUCK PARKING RESTRICTED ZONE, wherein trucks are restricted from parking for more than three hours, be and the same is hereby established on Calle Primera Road from Via de San Ysidro west to Via Tercero, and on Via Segundo from Calle Primera south to its terminus and on Via Tercero from Calle Primera Road south to its terminus.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
