WHEREAS, Robert Egger, Sr., as a member of the South Bay Chamber of Commerce, and the Tijuana Valley Water District originally donated land to the City of San Diego to be used for a recreation center; and

WHEREAS, the South Bay Recreation Center was constructed on said land; and



BE IT RESOLVED, by the Council of The City of San Diego, that the South Bay Recreation Center Gymnasium shall hereafter be renamed in honor of Robert Egger, Sr., and the City Manager be, and he is hereby authorized and directed to take all necessary and appropriate actions to accomplish the foregoing.
