A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, APPROVING AN AMENDMENT TO THE REVISED SAN DIEGO REGIONAL SOLID WASTE MANAGEMENT PLAN, 1982 - 2000, FOR THE SANDER PROJECT AT MIRAMAR.

WHEREAS, the Nejedly-Z'berg-Dills Solid Waste Management and Resource Recovery Act of 1972, hereinafter referred to as the "Act," requires each county, in cooperative with affected local jurisdictions, to prepare a comprehensive, coordinated solid waste management plan; and

WHEREAS, said Act also requires that such plan shall be consistent with state policy and any appropriate regional or subregional solid waste management plan; and

WHEREAS, said Act also requires that amendments to the solid waste management plan shall be subject to the approval by a majority of the cities within the county which contain a majority of the population of the incorporated area of the county; and

WHEREAS, the County of San Diego has prepared an amendment to the Revised San Diego Regional Solid Waste Management Plan, 1982 - 2000, for the proposed SANDER Project at Miramar, in conformance with the Act and has submitted this amendment to the plan to the cities in the region for approval; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the amendment to the Revised San Diego Regional Solid Waste Management Plan, 1982 - 2000, for the proposed SANDER Project at


Miramar is hereby approved, under the terms and conditions set forth in the Amendment of the San Diego Regional Solid Waste Management Plan San Diego Energy Recovery Project - SANDER, on file in the office of the City Clerk as Document No.
