WHEREAS, the Southeast San Diego Economic Development

Corporation (SEDC) entered into a \$1,413,648.08 grading and water

main contract with Chilcote Incorporated on September 6, 1985;

and

WHEREAS, partial financing for this contract, which benefits the Gateway Center East Redevelopment Area, was expected from a \$1,000,000 draw-down on a federal Housing and Urban Development (HUD) Section 108 authorization; and

WHEREAS, grading work has progressed rapidly and a progress payment of \$327,356.82 became due on September 30, 1985 but receipt of funds from the \$1,000,000 draw-down request had not yet occurred; and

WHEREAS, SEDC, recognizing the need for additional cash because of the rapid progress of work, amended the original \$1,000,000 draw-down request to \$2,300,000; and

WHEREAS, this amount of \$2,300,000 has been approved and is being processed by HUD with the payment expected in a matter of weeks but the contractor is now demanding payment of the amount of \$327,356.82 past due before continuing work; and

WHEREAS, this resolution advances an amount to bring payments on the contract current and permit work to continue; and

WHEREAS, the amount expended will be reimbursed as an expenditure credit to the General Fund Unallocated Reserve when

SEDC receives the funds authorized in the amended \$2,300,000 draw-down request; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$327,356.82 from the General Fund 100, Unallocated Reserve (605) to the Southeast Economic Development Corporation Fund No. 98360, for the purpose of serving as an interim budget supplement for expenses recited above.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby fully authorized and empowered to cause said sum transferred above to be expended solely and exclusively for the above declared purpose, said sum to be returned by SEDC as an expenditure credit to the General Fund 100, Unallocated Reserve (605) when SEDC receives the funds from the federal government.
