Douglas S. Johnson	General Services	\$2,250.00	Mr. Johnson is a Machinist with the Equipment Division. One year ago he earned a partial award of \$1,995.00 for his suggestion to fabricate oversize clamp shoes and clamp shoe sockets to reduce wear on the Leach packers. One year's experience has shown a savings of \$14,581.20. This is the remainder of his award.
Paul G. Zielins	General Services	\$1,615.00	Mr. Zielins is a Mechanic with the Equipment Division. One year ago he earned a partial award of \$1,545.00 for his suggestion to modify a clamp assembly and install a hydraulic lock. One year's experience has shown a savings of \$10,538.90. This is the remainder of his award.
Carmen C. Lutes	Building Inspection	\$ 990.00	Ms. Lutes is a Principal Clerk. She suggested modifying the PMT02U screen to include inspectors names and phone numbers. Actual savings of \$3,297.00 have been realized.
Helene Kaufman	Attorney	\$ 500.00	Ms. Kaufman is a Legal Secretary with the Litigation Division. She suggested the utilization of a reference guide of procedures and forms for all condemnation cases. Although savings are difficult to identify, this was considered to be a significant operational improvement.
