Al Kaufenberg	Planning	\$ 340.00	Mr. Kaufenberg is a Senior Drafting Aide in the Data Services Division. He suggested establishing a permanent file for Engineering Traverse Records. Actual savings of \$2,275.56 have been realized.
Vincent DeLeva	General Services	\$ 85.00	Mr. DeLeva was an Electrical Supervisor in the Communications & Electrical Division at the time he submitted his suggestion. He suggested contacting CalTrans regarding shared energy and maintenance costs for street lights which benefit State and City which earned him a partial award of \$840.00. One year's experience has shown a savings of \$3,078.92. This is the remainder of his award.
George M. Harkleroad	General Services	\$ 80.00	Mr. Harkleroad is an Electrician with the Buildings Division. He suggested the acquisition of #101 wire dispensers for electricians. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Pedro Y. Moreno	Clerks	\$ 80.00	Mr. Moreno is a Stock Clerk. He suggested the fabrication of straps for the six wheel cart used by the Records Division. Although savings are difficult to identify, this was considered to be a significant operational improvement.
