

RESOLUTION NUMBER R- 264576

ADOPTED ON NOV 25 1985

BE IT RESOLVED, by the Council of The City of San Diego, that it is the position of the City that houses on agricultural leaseholds should be repaired and maintained by the lessees at no expense to the City. Furthermore, the City shall cause houses which are significantly deficient in their physical condition, or if they cannot be provided with a satisfactory potable water source, to be removed with the cost of removal to be borne by the lessee. This policy shall be incorporated in future agricultural leases.

BE IT FURTHER RESOLVED, that proceedings to abate houses No. 3 and No. 5 on TMY Farms leasehold in San Pasqual Valley may be delayed for an additional 60 days in order to allow for the completion of negotiations which may lead to the solution of the problems with regard to said houses No. 3 and No. 5.
