

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. JOHN C. HENBERGER CO. INC. and 2. AMERACE CORPORATION, STIMSONITE PRODUCTS are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of 2-PART PAVEMENT MARKER AND REFLECTIVE RAISED PAVEMENT MARKERS as may be required for a period of one (1) year beginning December 1, 1985 through November 30, 1986, per prices on file in the Purchasing Department as follows:

1. JOHN C. HENBERGER CO. INC. - for Item 1, a. and b. Epoxy; terms net 30 days, plus sales tax, with an option to renew contract for three (3) additional one (1) year periods, price increases not to exceed 20% of original year prices.
2. AMERACE CORPORATION, STIMSONITE PRODUCTS - for Items 2 and 3, Pavement Markers; terms 1% 20 days, plus sales tax, with an option to renew contract for three (3) additional one (1) year periods, price increases not to exceed 3% of original year prices the first year, 6% the second, and 8% the third year.
