

RESOLUTION No. R- 264580 (R-86-907)



BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the award to BALTIMORE PAINT & CHEMICAL CO., DIV. THE SHERWIN-WILLIAMS CO. for furnishing INSTANT DRY TRAFFIC PAINT (WHITE) which was authorized by Resolution No. 264187, adopted on October 14, 1985 is hereby cancelled due to inability of vendor to fulfill the terms of their bid.

2. That the second low bid of CENTER-LINE PRODUCTS, c/o JOHN C. HENBERGER CO., INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing INSTANT DRY TRAFFIC PAINT (WHITE) as may be required for a period of two (2) years beginning December 1, 1985 through November 30, 1987 at a cost of \$5.56 per gallon for a total estimated cost of \$41,255.20, including sales tax, plus refundable deposit charge of \$10.00 each with options to renew contract for two (2) additional one (1) year periods, with price escalation after the first year based on the Producer Price Index, as published by the U.S. Department of Labor, Bureau of Labor Statistics, for the groupings "Prepared Paint" and "Paint Materials".
