WHEREAS, in conjunction therewith, it is planned to promulgate and execute a three-party agreement between SANDAG, MTDB and the City in which SANDAG will agree to and be responsible for developing the Financial Strategy to finance the proposed North University City Transit Loop; and

WHEREAS, the work program proposed by SANDAG to MTDB is set forth as Exhibit 1 to the Amendment Number 1 to the agreement between the City and MTDB; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, a FIRST AMENDMENT TO FINANCIAL AGREEMENT for the North University City Transit Study between the Metropolitan Transit Development Board and The City of San Diego, pursuant to the terms and conditions of the Amendment Number 1 to said agreement, on file in the office of the City Clerk as Document No. RR-264587.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, an agreement between The City of San Diego, MTDB and SANDAG for the purpose of SANDAG establishing an assessment district to finance the proposed North University City Transit Loop/Shuttle System, pursuant to the agreement therefor marked MTDB Document No. 00-86-543, a copy of which is on file in the office of the City Clerk as Document No. RR-
