WHEREAS, the Planning Commission of The City of San Diego held a public hearing on November 7, 1985, to consider the proposed amendment of the MIDWAY COMMUNITY PLAN and General Plan; and

WHEREAS, the Planning Commission approved and recommended to the City Council adoption of the amendment of the MIDWAY COMMUNITY PLAN; and

WHEREAS, it is the intention of the City Council to conduct a public hearing on proposed actions that will result in changes to the PROGRESS GUIDE AND GENERAL PLAN during the year, but such changes shall not become effective until enacted at the semi-annual hearing conducted for the purpose of amending the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider the amendment of the MIDWAY COMMUNITY PLAN; and

WHEREAS, the Council of The City of San Diego, by majority vote, approved the amendment of the MIDWAY COMMUNITY PLAN; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

- 1. That this Council hereby approves the amendment of that plan entitled MIDWAY COMMUNITY PLAN, a copy of which is on file in the office of the City Clerk as Document No. R-264615, by incorporation therein of the MIDWAY COMMUNITY PLAN.
- 2. That the amendment of the MIDWAY COMMUNITY PLAN shall become effective upon adoption of an appropriate amendment of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO incorporating said plan at the next scheduled omnibus hearing.
