WHEREAS, the City of Chula Vista is desirous of filing an application with the Local Agency Formation Commission ("LAFCO") for the proposed Otay Valley/Palm Avenue Reorganization, which would involve the detachment of a 566-acre territory from the City of San Diego; and

WHEREAS, LAFCO staff does not normally accept an application for a reorganization proposal where the City from which territory is proposed to be detached has indicated opposition to such proposal; and

WHEREAS, Council Policy 600-1 contemplates that City Council action on reorganization proposals involving the City of San Diego shall consider various factors, including but not limited to the results of a fiscal impact analysis and the extent of jurisdictional problems that might be created; and

WHEREAS, laws relating to a reorganization that involves the detachment of territory from a city provide that the conducting authority shall terminate the proceeding if a resolution or written protest against the reorganization is filed prior to the conclusion of the hearing by the city from which territory would be detached; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it does not, at this time, oppose the filing of an application by the City of Chula Vista for the proposed Otay Valley/Palm Avenue Reorganization.

BE IT FURTHER RESOLVED, that it specifically reserves all rights to terminate the reorganization proceeding prior to its conclusion.

BE IT FURTHER RESOLVED, that it hereby directs City staff to undertake and complete an analysis of the proposed Otay Valley/Palm Avenue Reorganization, and to report the findings of such analysis to the City Council prior to any public hearing to be conducted on this matter by LAFCO.
