A RESOLUTION OF THE CITY COUNCIL EXPRESSING  
GRATITUDE FOR CONTRIBUTIONS TO THE NORMAL  
HEIGHTS CANYON RESTORATION EFFORT.

WHEREAS, after the most devastating fire in San Diego City history on June 30, 1985, the Canyon Rim Fire Prevention Task Force was formed to explore ways to prevent such tragedies from happening again; and

WHEREAS, the Task Force was charged with, among other things, looking into what would be best for both the burned and unburned canyon slopes; and

WHEREAS, the Task Force recommended that the burned area be reseeded with a special seed mixture that is fire-retardant, soil-binding and drought-resistant; and

WHEREAS, the California Conservation Corps has been retained to broadcast the seed mixture and construct low-soil berms to prevent rainwater run-off from going into the canyon and furthering the erosion problem; and

WHEREAS, this special seed mixture was identified and the cost to restore the affected area was set at \$7,500; and


WHEREAS, according to the San Diego City Charter, public monies could not be spent to benefit private property; and

WHEREAS, McMILLIN DEVELOPMENT, INC. generously answered the pleas for private sector funds by their contribution to the Normal Heights Canyon Restoration Fund; and

WHEREAS, the contribution by McMILLIN DEVELOPMENT, INC. made the reseeding effort possible; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of said City, does hereby commend McMILLIN DEVELOPMENT, INC. for its generous donation to help restore the canyons of Normal Heights.
