APPROVING MAP OF PARCEL MAP T.M. 84-0314.

BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by Patrick O'Malley, L.L.S., entitled "T.M. 84-0314 being a division of a portion of Pueblo Lot 1278 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map Thereof by James Pascoe, a copy of which was filed in the office of the County Recorder of San Diego County and is known as Miscellaneous Map No. 36, together with an unnamed street as vacated and closed to the public use, together with a portion of Genesee Avenue as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; Luigi Terrace and said street is hereby declared to be a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Genesee Avenue, adjacent and contiguous to Parcel 1, all as shown on this map within this subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of general utility and recreation facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the building-restricted easement over, upon or across Parcel 1, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of general utility and recreation facilities; and the building-restricted easement, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.


