## RESOLUTION NUMBER R- 264665 ADOPTED ON DEC 1 6 1985

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where the portion of street to be vacated consists of a portion of a street or highway that has been impassable for vehicular travel and upon which no public moneys have been expended for maintenance; and

WHEREAS, the abutting property owner has requested the vacation of Old Mission Gorge Road and Road Survey 627 in Lot "E" of Partition of Lot 70 of Rancho Mission, all within the boundaries of Mission Gorge Margerum Subdivision (T.M. 84-0885) to facilitate development of his property; and

WHEREAS, no public moneys have been spent on the maintenance of Old Mission Gorge Road and Road Survey 627 within the five proceeding years; and

WHEREAS, Old Mission Gorge Road and Road Survey 627 have been impassable to vehicle traffic for five years; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That Old Mission Gorge Road and Road Survey 627 in Lot "E" of Partition of Lot 70 of Rancho Mission, all within the subdivision boundaries of Mission Gorge Margerum (T.M. 84-0885), as more particularly shown on the attached Exhibit "A," which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.
- 2. That this resolution shall not become effective unless and until the Mission Gorge Margerum Subdivision (T.M. 84-0885) has been approved by Council action. In the event that the subdivision map is not approved by the sixth anniversary date of this resolution, this resolution shall become void and of no further force or effect.
- 3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this resolution, with Exhibit "A," attested by him under seal, to be recorded in the office of the County Recorder.


