RESOLUTION NUMBER R- 264673

ADOPTED ON DEC 16 1985

WHEREAS, VONS REALTY CO, a California corporation, LA JOLLA INVESTORS, a general partnership, SAN DIEGO TRUST AND SAVINGS BANK, a California corporation, and PACIFIC INVESTORS GROUP, a California corporation, have requested an exchange of water easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the acceptance by the City Manager of those deeds of VONS REALTY CO. dated August 28, 1985; LA JOLLA INVESTORS, dated August 13, 1985; SAN DIEGO TRUST AND SAVINGS BANK, dated July 19, 1985; and PACIFIC INVESTORS GROUP, dated August 13, 1985, all executed in favor of The City of San Diego, conveying to said City water easements in portions of Parcels 1, 2, 4 and 5 of Parcel Map No. 13620, as more particularly described in said deeds, copies of which are on file in the office of the City Clerk as Document Nos. RR- 264673-1, RR- 264673-2, RR- 264673-3 and RR- 264673-4, is hereby approved.


2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No.

RR-264673, quitclaiming to VONS REALTY CO., a California Corporation, LA JOLLA INVESTORS, a general partnership, SAN DIEGO TRUST AND SAVINGS BANK, a California corporation, and PACIFIC INVESTORS GROUP, a California corporation, all of the City's right, title and interest in the water easements in portions of Parcels 1, 2, 4 and 5 of Parcel Map No. 13620, as more particularly described in said deeds.

3. That the City Clerk is hereby authorized and directed to deliver all of the deeds, and a certified copy of this resolution, attested by him under seal, to the Engineering and Development Department for further handling.
