RESOLUTION NUMBER R- 264675

ADOPTED ON DEC 16 1985

WHEREAS, AB 2325 (Stirling) replaces existing state law on school financing with a comprehensive program to plan and finance school facilities and establishes a statewide scale for imposing developer fees and provides a standard definition of local school district resources that can be made available for school facility purposes; and

WHEREAS, this bill has been inactive because of division within the education community over whether to support it; and

WHEREAS, the Rules Committee on November 25, 1985 reviewed IRD Report No. 85-109 and approved the recommendation therein to retain the bill in inactive status until it can be determined that the school community which will be affected by the bill supports it actively; and

WHEREAS, the Rules Committee now forwards the matter to the full Council for action; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation to retain AB 2325 (Stirling) on inactive status, as discussed and set forth in IRD Report No. 85-109, dated November 20, 1985, be and the same is hereby approved and adopted.
