
ADOPTED ON DEC 16 1985

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Burkett & Wong Civil & Structural Engineers, for design consultant services in connection with providing offsite improvements on 15th Street, 16th Street, Imperial Avenue and Commercial Avenue, adjacent to Block 53 of Shermans Additions and on 11th Street, 12th Street and J Street, adjacent to Block 197 of Hortons Addition, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR- 264684 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$13,400.00 from Fund 18520, CIP 37-184, Transient Day Center and \$8,600.00 from CIP 37-193, San Diego Rescue Mission Public Improvements, Capital Outlay Fund 30245, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.


